Because snowmobile access to the park is highly regulated, one of the best ways to get guaranteed access into the park is through an official concessionaire such as Three Bear Lodge. These tours always sell out, and the small amount of non-commercial passes available to the general public are distributed by a lottery where demand vastly exceeds supply. Even if you don't win the prize, you should put a winter excursion hosted by Three Bears Lodge on your bucket list, because it is one of the best ways to be guaranteed to see the park in winter from a snowmobile.

Whatcom and Skagit County sno-parks were visited by State Parks Winter Program head Corey Tolar and staff member Travis Travis in early February. These gentlemen kindly took two days out of their busy schedules to meet with club members, Forest Service staff, and visit key snoparks including Glacier Creek, Canyon Creek, and the Mt. Baker NRA (National Recreation Area). The visit provided the opportunity for the snowmobile clubs to share local issues of concern and look for ways to better work to-

gether to serve the snowmobiling public.

The Northwest Glacier Cruiser's hosted the annual Youth Day again on February 11th, at the Mt. Baker NRA Sno-Park. As you will see in the club news photos, the event was well attended, and with so many kids in full rally mode. The parents and adults were all smiles as well. I think it's safe to say this may be the largest kids event on the snow in Northwest Washington outside of commercial ski areas. Having an older 'kid' myself, this event always brings back so many fond memories of involving our youth in our favorite sport. One of my friends commented, "I really needed this day with my kids". Safety is number one in these storms and must be practiced with your riding group. I learned one useful fact from our NWAC (Northwest Avalanche Center) forecaster recently. The key difference between 'High' and 'Considerable' forecasts is that with a 'High' rating, avalanches are expected to occur naturally, and with a 'Considerable' rating, they are expected to need a human trigger. The size and potential danger of avalanches with these ratings is the same. This was helpful for me to learn as we have many 'Considerable' days, and now I know they are basically 'High' days if I'm riding terrain.

Happy March everyone!

We recently held the annual WSSA Winter Rendezvous in Yakima. Thanks to everyone who put forth the time and energy for this great event. I was impressed to see most of the rides were full and well attended. On Sunday I took the opportunity to ride out of Little Naches for the first time and went over to the Greenwater cabin bright and early in the morning. We passed R&R Grooming in the groomer on the way up and got to the cabin about an hour before they showed up. We got the fire in the stove going and helped set up the chili feed for all the riders who showed up during the day. We had a pretty easy time finding the cabin even in the poor visibility in the meadows that day.

Now for the fun part. In the good old social media world there was some conversation about how the "grooming world is mis-

managed and it should be like Oregon or Idaho or Canada" blah blah blah. My good friend Brian Bilderback felt like he deserved to pay for my bar tab and brought my name into the conversation on social media. Thank you Brian.

First off, it's hard to say a program is being mis-managed when the budget is public information; each year's budget is proposed and voted on by the SMAC (Snowmobile Advisory Committee), which consists of individuals from all outdoor backgrounds volunteering their time. So, if any of the social media financial/budget experts would like to volunteer their time and be able to ascertain the grooming budget is truly being mismanaged, please step forward.

Second, our grooming program is severely UNDER-FUNDED. When you begin to compare retail prices by looking at top-of-the-heap sleds in 2000 to the top guns in the same class in 2023, the picture changes dramatically. For example, the retail price for a top-dog Polaris or Ski-Doo 600-class snow-mobile was approximately \$6,599 in 2000. In 2023 one of the most inexpensive entry-level snowmobiles for adults set you back around \$8,000-\$10,000 (Continued on page 10)

while the costs of the most costly high-performance snowmobiles vary from \$17,000 up to \$23,000! That's almost a 400% increase in 23 years. However, the costs to register your sled and what goes into funding the grooming program have not kept up at the same pace.

It's been said, posted, documented and talked about a million damn times. Our grooming program is funded by sled registrations. For example, my 2018 snowmobile cost \$90'ish dollars to register this year. My sled registration initiated a refund from the State Gas Tax Program that goes into the grooming budget as well. For my \$90'ish dollar sled registration I also received a sno-park pass valued at \$50. So all in all (these are general numbers) I pay \$90'ish dollars to register my sled, receive a \$50 sno park permit, and in conjunction with the gas tax rebate approximately \$100 per registered sled goes into the grooming program.

Now, because I don't identify as a certified social media financial/budget expert, BUT I do attend the SMAC meetings where they review and approve the socalled mis-managed funds, and attend the grooming council meetings to stay informed, I do know the Snowmobile Program budgets for grooming operations, sno-park plowing and sanitation, law enforcement, maintenance/ repair of state-owned groomers, and projects local clubs bring to the table that help our trail systems. In a nutshell, let's say the Snowmobile Program starts with \$2.5 million. I can guarantee the grooming programs across the state don't see that \$2.5 million. One more thing, to those who say "my tax money gives me access to our lands" or "it's my right" to have free access to these lands... you are almost correct. There are two FOR SURE things that give your access to this terrain. The first thing is your left foot, the other thing is your right foot. If you choose

other avenues to recreate the land managers have costs associated with that. Also, if your snopark is on Forest Service Land, State Parks signs an access agreement, (and of course fees are associated with that agreement), that allows the motorized user group to recreate out of that sno-park. Keep that in mind if you continue to harass State Parks and wonder why your snopark access agreement doesn't get renewed.

Ok, so do you want to help? First, we really need people to register their sleds. Second, take a minute and think about how much you are willing to pay to register your sled so our grooming program can be funded at the levels they need to be. You want double the amount of grooming? Paying double keeps us in the same boat. You want a full 16 week grooming season? (Pray for that type of snow!) Paying double keeps us in the same position we are in now. How about when everything (cars and trucks) goes electric someday and we no-longer receive a rebate from the gas tax to help fund our grooming program? That's about 50% of your current grooming dollars... paying double puts us in the same position we

Want to help? Join a club that has a grooming coordinator who understands what they are doing and doesn't spread misinformation like some sort of plague. Join a club that focuses on the issues within our state and not about the 'hashtag' or the 'GoPro' on their helmet.

Join WSSA. It does ALOT for the snowmobiling community that you may not see right up front. It helps keep our recreational world connected to all the land managers and organizations that have an influence within our sport. Please help. We need it.

TO ALL WSSA CLUBS

WSSA is again offering a grant program to be made available to WSSA member clubs for trail and trailhead improvements such as brushing or clearing of trails, signage, gravel, bridges, gates, rental equipment for such work, parking lot repair or use as matching funds for NRTP grants.

WSSA wants to keep this as simple as possible. The grant limit is \$1000 per club. The club applying for a grant must have a current membership in WSSA and no outstanding WSSA Grants that are not completed. The deadline for the application is April 15th 2023. The goal is to award grants by June 15th 2023.

The process for the grants are as follows:

All applications for the grants go to Chairman Jim Kingman. Jim then forwards the applications to the appropriate District Reps for input. The district reps will review and report back to the Grant committee Chairman. District Reps are required to sign application to be considered for a grant. The chairman will then forward all applications to the committee for scoring. Sometimes there are more applications than there are funds to handle all of them. The committee will decide off of the scores if some get partial funding or if the lowest scores don't get funded. Total grant money for 2023 is unknown until the March Budget meeting

Please be sure to complete the applications and attach a map and landowners permission letter.

Winter Knights

"No soldier left behind", or something similar, is the recurring mantra often heard in military circles. It's such a popular saying tended to. After several miles at over 50 mph average with no sign of her, my worries became disturbing. Two of my rider buddies

that it's woven its way into the mainstream and adopted to fit any situation where a goal with objectives that may have unintended consequences. This concept often comes into play whenever my buddies and I trek off the grid astride our high-horsepower machines and attempt to conquer whatever it is that drives us into this madness. Unfortunately, not everyone in our clan finds continual success in their efforts. Each one of us has been a victim of circumstance at times, and if it wasn't for the unspoken comradery we share, someone just might not make it home. Sullen thought, but real. Interestingly enough, the latest example of this mantra occurred not in the dangerous backcountry, but on a set of groomed trails on a club ride, not too long ago. We held the usual rider meeting in the parking lot and then instructed all riders to line up at the trailhead to be accounted for. I took my spot at the lead while others fell into place according to their perceived riding speeds. My wife took her place in the sweep position as I began counting each sled down the line. I counted three times, and each time came up one rider short. I walked the line, counting once again, this time out loud. When I got near the end of the line, I noticed who was missing. I approached her husband and asked where she was. His only answer was a set of shrugged shoulders and a look of dismay. A voice from the line-up said she might have left with the only other group of riders in the lot that morning, mistaking them for us. A thorough glance of the parking lot proved no one was around, so the decision was made to head out and hopefully come across her somewhere along the trail. Admittedly, I was a bit nervous, and as ride leader, felt a certain uneasy responsibility for her disappearance.

Luckily, it was snowing lightly and had been for a few hours before we arrived, so it was easy to pick out the sled trails of the group ahead of us. At the first intersection, signs indicated the three-plus-one riders turned right, a direction we did not originally intend to go. I led our group of eleven in that direction until the next intersection, where a left turn was made. At this point, I figured if I took off at a fast rate, I might be able to catch up to her, knowing this trail had several miles before the next intersection and assuming she, as an older lady, would not be riding near the speed I intended to. After several miles at over 50 mph average with no sign of her, my worries

were right behind me when we stopped at the next intersection. We all stared at each other in amazement for a few moments, no doubt with the same thoughts, as the remaining of the eleven caught up to us, one by one.

The fresh sled trails had all turned right, down a trail heading far away from our planned destination for the day. I asked my two buddies to head down that trail, as far and as fast as they were comfortable, to see if they could find her before the day was a total loss. They agreed, and the rest of us sat there trying to figure out our next move in case she wasn't found. Many thoughts went through my head. I remembered seeing the three guys unloading their mountain sleds as we began gathering earlier for our rider meeting. Aggressive looking sleds, they were. I also noticed that each rider wore an inflatable avalanche backpack, along with shovels and probes sticking out of various places. These guys probably had no clue this lady was hot on their tails, trying to keep up as they raced toward the high country. I began to worry just how far she would try to follow them. The 'no one left behind' engrained in me played with my emotions as questions flooded my thoughts. What if we never found her? Would she know how to get back to the parking lot? What if she crashed trying to keep up with those guys? Why wasn't her husband more worried than I was? Would this be the ultimate failure in ride leading that no one ever wants to suffer? I was a mental wreck.

Time has a funny way of warping itself when emotions are involved. To me it seemed like an eternity, but to those actually watching the clock, it was about ten minutes or so when one of my buddies came racing back from the lost trail with his thumb held high. Moments later the lady arrived, closely followed by my other buddy that, as I learned later, was not going to let her get lost again. Spontaneously, we all began applauding as the group of twelve was now back into one. I expected the husband to come forward and at least have some words for her, but that didn't happen until the next check-up/intersection stop. In the end, it all worked out and everyone was safe and relatively sound.

My heart skipped a few beats that day. I had never encountered this before and was-n't sure how to best handle it. The thought of losing someone on a ride to any level of disaster is unbearable, and I'm thankful to have so many great buddies riding with me, both on and off the trails, (Continued on page 15)



event! The Northwest Avalanche Center (NWAC) will be present as well to share avalanche safety and education.


On March 25th, Bill Yager will be hosting a sled recovery ride out of the Crystal Springs Sno-Park. This is a great opportunity to ad-


We had three days of rides that were just phenomenal! I know everybody who rode came back with a tired grin on their face.

ACSA Mountain Riding Area Meeting

The American Council of Snowmobile Associations (ACSA) Mountain Riding Area meeting was held in Alpine, Wyoming, on Friday, February 24th, at the Flying Saddle Resort. Prior to the meeting, Avalanche training was provided by the Bridger-Teton Avalanche Center along with Wyoming Parks. Following are notes and highlights of the meeting which was attended by 30-35 people from nine states including MI, IL, SD, NE, WY, UT, ID, WA and OR.

Sierra Snowmobile Foundation Raffle - Dan Long, ACSA President, won the snowmobile.

ACSA Update – Christine Jourdain, Executive director, indicated the Fly-In will be held at the Residence Inn, Washington DC, from April 23rd-25th. There will be an ACSA meeting on the 23rd, speakers on the 24th, and visits to the 'Hill' on the 25th.

ISC 2023 - The International Snowmobile Congress (ISC) will be in Moline, IL, June 7th-10th. The host hotels are the Wyndham and The Element (Marriott). Details on speakers, etc are being finalized. There will be a 'road trip' south to Muscatine on Wednesday. A FOSPAC (Friends of Snowmobiling Political Action Committee) event consisting of outdoor games is being planned.

ISC 2024 - The event will be in Green Bay, Wisconsin.

ACSA Awards - Youth, Club, Family, Dealer, Snowmobiler OTY, etc: Need to be submitted by April 1st.

Economic Study presentation – Kim Raap, Trailswork Consulting, gave a presentation on a recently completed economic study for Wyoming. The study was conducted by the University of Wyoming. The study revealed a total economic impact of \$255M with \$193.8M direct, \$61.2M secondary, and \$17.6M in government revenue. A brief overview will be available soon and the full report is available on the snowmobilers.org website.

Avalanche Center presentation – The Director of the Bridger-Teton Avalanche Center described the mission (public safety, data collection, information exchange, accident reporting and community engagement) of the centers. There are 22 entities in 12 states with the U.S. Forest Service running 14 of the centers. An additional center may be added in Southeast Idaho in the future

State reports: Each of the states represented provided a brief report on snowmobiling in their respective states.

ACSA Scholarship: ACSA has created a committee to do the groundwork for establishing a scholarship program, which will be discussed/presented at ISC. As a kick-off to build up funding, an auction was conducted and \$1,040 was raised. It is also anticipated remaining funds from the Bill Townsend Memorial Scholarship Fund may be used to support an avalanche training stipend. More to come on these two items.

Due to closed roads, cancelled flights, and other commitments, several attendees spent a day or two 'relaxing' at unanticipated locations or cancelled their attendance. Given the challenges getting to Alpine, the meeting went well and afforded a great opportunity for exchange of information. The weather, once there, was great; not -26F as it was a week earlier!

Order to Restore Wild Bison Population

Recently Interior Secretary Deb Haaland signed an Order to restore bison populations across the country, using \$25 million from the Inflation Reduction Act passed by Congress last year.

Haaland said the Order will improve the department's efforts to restore the wild populations and the nation's prairie grassland ecosystem by working with other federal agencies, states, tribes and private landowners.

The Order notes the American bison, the centerpiece of the Interior Department's seal and the U.S. national mammal since 2016, "is inextricably intertwined with grassland ecology and American culture." Bison also are important to many Native American tribes in the Great Plains.

Waters of the U.S.

Ryan Zinke (R-MT), former Interior Secretary, who returned to the House this year, said at the Conservative Political Action Conference that the GOP's new House majority gives it the power to completely defund EPA's 'Waters of the U.S.' (WOTUS) regulation.

"For those that don't follow it, imagine the federal government taking jurisdiction over waters that are in all intermittent streams, cow ponds, and vernal pools," Zinke said, claiming about 90% of Montana's waters are covered by the EPA policy released last year. "But if the federal government can have jurisdiction in your backyard over a water pond, you know we're in trouble."

Lawmakers are also working to stop the regulation using the Congressional Review Act, and both chambers are likely to vote on the measure soon.

EPA Eyes Broadening E-15 Sales

The Environmental Protection Agency (EPA) plans to eliminate a gasoline volatility waiver for 10% ethanol fuels in eight states next year because the waiver would lead to an increase in harmful emissions during the summer months, officials said.

The move opens the door to year-round sale of gasoline containing 15% ethanol, called E15, in those states.

The agency issued a notice of proposed rulemaking recently in response to a petition last year from the governors of the eight states. They had asked EPA to kill the '1-psi waiver' for E10 fuel, saying it would provide parity between that fuel and E15, since the two fuels' volatility is nearly identical.

Delist The Grizzly Bear?

New legislation from Congresswoman Harriet Hageman (R-WY) could direct U.S. Secretary of the Interior Deb Haaland to remove the Yellowstone area's grizzly bears from the federal endangered species list.

"The Greater Yellowstone population of grizzly bears should have been removed from the endangered and threatened species list 15 years ago," Hageman said in a press release. "The grizzly bear has been listed since 1975, and its original recovery goal was 500 bears. Today, the number of bears is more than double that goal and has become a threat to people and livestock in Wyoming.

"The goal of the Endangered Species Act should always be to stabilize declining populations of wildlife, then remove the species from the list when recovery goals and benchmarks have been met. Unfortunately, like we see in all facets of the federal government, once an agency has control, they are loath to surrender it for any reason."

Ice Bridge From Michigan to Canada

There is a more exciting, temporary way to travel between Michigan's Upper Peninsula and Canada each winter season — although, modes of transportation are limited and you still have to check in with customs.

An ice bridge forms between Drummond Island in Chippewa County and St. Joseph Island in Ontario, Canada, during the winter months each year.





Once the ice has frozen to a safe depth, locals are able to enjoy winter activities on the trails.

The Drummond Island ice bridge in the Eastern U.P. officially opened for the season on Friday, February 10th, and will remain open until the ice starts to melt around springtime, making travel dangerous.

What can people ride on the ice bridge? Those looking to have some winter fun can snowmobile, dog sled, cross-country ski, aero sleigh, or bike on the ice bridge connecting the two islands. Cars and trucks are not permitted.

The trails are wide, free from congestion, and marked with evergreen trees across the ice to prevent snowmobilers from getting lost while riding in the dark or during inclement weather, according to the Drummond Island Tourism Association.

Did You Know???

As the steward of the 193-million-acre National Forest system, Forest Service Chief Randy Moore has a supply and demand problem; millions of trees to remove from overstocked forests but not enough places to put them

So the Forest Service is putting the economics of timber to a test, shipping sawlogs more than 1,000 miles from the West Coast to the Black Hills of Wyoming and South Dakota — and hoping the experiment sticks. Moore told E & E News he's not sure how long the timber transport pilot project will last but that his main goal is to keep mills open in places like the Black Hills, where his agency's own policies to limit timber harvests on the 1.2-million-acre Black Hills National Forest have been blamed for squeezing local mills.

day... That's the reason this Snoflyer is run- ties, replenishment times of 0-80% can be ning late and the Winter Rendezvous coverage is mostly missing. My wife would say I've got too many commitments betweens WSSA, two local clubs and the local grooming council. Maybe. But the last three weeks have been a blur between leading a ride at Rendezvous, providing lunch the next day, displaying the WSSA safety trailer at the Yakima Ski-Benders' Kids Ride the next weekend, hosting WSSA's annual Military Appreciation Ride the following week, and then manning a WSSA-sponsored checkpoint at the Sno-Jammers Fun Run two days later. Add in the prep and trailer configuring for these events... and the fact I may or may not have a personal life... hopefully you get the picture.

Pain is a reminder to not do stupid stuff. At least that is what I keep telling myself. I injured my knee on a Sunday ride when I dropped off a small cornice I didn't see in foggy/snowy/flat light conditions and banged it on the handlebars. While preventable, this wasn't really a case of me doing dumb stuff.

But fast-forward a week when I was moving too fast just off the trail and was coming back on the trail and didn't see the deep hole until too late; the choice was to brake and fall into the hole or nail the throttle and hope to clear it... I made the wrong choice and hit the far side at speed and the same knee hit the handlebar AGAIN. And I was stuck in the hole anyway. I came away with a swollen knee and tender tendons leading down to my right foot. It hurt so bad the next day I actually only rode a short, sit-down trail ride... wincing the whole way.

What lessons should I take from this? Maybe wear some protective gear? Slow down and better assess the situation? Realize I'm not as young or talented as I sometimes think I am? Whatever... I'm still nursing the knee though.

Electric snowmobile charging is now getting much faster for Taiga Motors.

Taiga Motors recently announced its electric snowmobiles will soon have access to a software update enabling DC fast charging for their snowmobile's battery hardware.

The three sleds introduced feature a 27 kWh battery pack, with an estimating range of about 60-87 miles. But the best charge rate you could achieve was on a 240V level 2 charger which takes about 3.5 hours. With

Publicity Secretary the DC fast charging capabiliachieved in 30 minutes. With the update,



owners can plug into any Taiga charger or standard EV DC fast charger using the CSS 1 combo connector. Yeah, that last part is gibberish to me too, but I guess if you own a Taiga, you probably understand it.

Lot's of us have ridden with our young kids in front of us, but there is a reason I've run the PSA at right. There can be deadly consequences.

Electric Snowmobiles from Ski-Doo and Lynx introduced. Expected to hit the market next year, they will feature what BRP refers to as Rotax E-Power technology with a range of up to 31 miles. Pretty laughable, right?! The models will include the Ski-Doo Grand Touring Electric as well as the European-only Lynx Adventure Electric.

BRP claims the machines will provide a "unique ride that is inviting for first timers to experience the world of snowmobiling." Initially these machines are only going to be offered to

ety' outfitters, which are 'BRP-certified' quide companies. BRP claims their goal is to reduce their carbon footprint.


I'm a Ski-Doo guy through and through, but this should just be a bad joke. Maybe they should just rebadge Taiga machines.

This is pretty low. It was reported thieves stole a snowmobile from the scene of a fatal collision in Northern Minnesota. A woman was killed while riding her snowmobile when she collided with a semi-trailer. Before the family could retrieve snowmobiles from the crash site, somebody stole one of them. Authorities followed snowmobile tracks and did find the machine and a man and woman have been charged with felony theft. (The machine was returned to the family.)

Avalanches - Avoid them!

Seems like simple advise. The reason I bring it up is because in February a Wisconsin man was swept down into a creek drainage in Wyoming where he was buried under his snowmobile and 6+ feet of snow.

His group conducted a beacon search, and found him with avalanche probes, but it took



about an hour and half to dig him out. In addition to the snow depth, the water in the creek interacted with the snow to create slush.

You can have an airbag and beacon and your friends can all have shovels and probes, but your odds of rescue are pretty much zero

in a situation like this as you will run out of the most precious commodity: time. The above incident demonstrates how deadly 'terrain traps' — areas like gullies or streambeds where even a small amount of snow can bury a person under feet of debris — can be in the backcountry. Other avalanchecaused killers can be sliding into trees, rocks or sending the victim over a cliff. In addition to thinking about a slide risk, look around and see where you or your friends might end up if a slide were to occur; make that part of your decision as well.

'3 Old Guys' gear up for March adventure. A snowmobile trek from Minnesota to Alaska. Paul Dick, Rob Hallstrom and Rex Hibbert snowmobiled from Grand Rapids, MN, to Churchill, Manitoba, in 2019. They are ready for this challenge now, a 4,000-mile trek from Grand Rapids to Fairbanks, AK. They call themselves '3 Old Guys' and are all ex-snowmobile racers and long-distance riders. Ages range from 65 to 72. They all have completed 'Cain's Quest', an extreme 2,000+ mile snowmobile race in Labrador. Canada.



The course they've charted will take them mostly on groomed trails from Grand Rapids to Flin Flon, Manitoba, and beyond that, a backcountry route that includes portions of Reindeer Lake, Wollaston Lake and Lake Athabasca in northwest Saskatchewan. They'll follow ice roads to the Great Slave River and up to Great Slave Lake, the Mackenzie River to the Arctic Ocean at the northern tip of the Yukon, cross the Richardson Mountains to the Porcupine River, and then southwest to the Yukon River, and then finish the trip on the Yukon Quest sled dog trail into Fairbanks.

What machines will they ride? New Arctic Cat Norseman 8000X snowmobiles. Each of them will pull tow-sleds loaded with supplies, including enough spare snowmobile parts to handle almost any breakdown that might occur. Each will also carry 30 to 40 gallons of

gasoline. In addition to food, gasoline and spare parts, their gear list includes an Arctic Oven Igloo-model 'hot tent', a woodstove, and sleeping bags rated for -60F. They'll also have a couple of different satellite communicators which will allow them to send text messages and let a few people follow their course in real-time.

They'll stay in hotels where possible, but figure the camping gear will probably get plenty of use. On the Mackenzie River, they've made tentative plans to stay in a trapper's cabin with a trapper one night.

If all goes according to plan, the adventure-seekers anticipate the trip will take about a month. They'll fly home at the end of the adventure and figure out how to get their snowmobiles back to Minnesota later.
