As WSSA moves forward through 2020 and 2021 you will see other adjustments to our budget as a result of not having income from the cancelled 2020 Expo. Please have patience with the WSSA Board as they make these difficult decisions. There is light at the end of this tunnel!

The WSSA Board is still talking about hosting the 2023 International Snowmobile Congress (ISC). Many of the Board members are searching for a location and somebody to take the reins and help make this happen. If you are interested in taking the lead and you have experience in large events like this, please contact me soon. I think WSSA needs to have a GO or NO GO by no later than December 15th, 2020. No pressure.

Elections for WSSA Board members are coming up real soon. If you are interested in getting involved at this level of commitment, please contact our nominations chair, Jim Kingman, or your local District Rep. I will be running for President and would appreciate your **vote.** My platform continues to be 'building bridges and not walls'. I know WSSA revenues are down, but I think the 50% cut will hurt the aspiring college student more than it does WSSA. Nevertheless, that is what WSSA chose to do.

However on a more positive note, I'm glad to announce that WSSA chose to donate and support the development of the Washington Hometown mapping app by Jennifer Hackett. It is a great tool you can download to your

In addition to making sure your snowmobile and safety equipment are in good working order, I encourage you to make sure your health and body are in good working order too. Please get out and do a brisk daily walk or short run, or other cardiovascular exercise to help with those higher elevation sled ventures and those days you are doing a lot of digging. I personally have shed a few pounds myself this year and I'm feeling great and I'm ready to ride! I stumbled across something that significantly helped me a great deal with more energy; feel free to reach out to me via e-mail or find me on Facebook and I will share it with you. 
# Mountain Trails Grooming Association

We ended up using a couple of snowmobile ski dollies and a floor jack to maneuver the new

frame into position. We also replaced a compactor bar spring on the '08. We installed a cell phone antenna on the new cat as well as an armrest on the passenger seat.

"The diesel has been delivered this month, so I have requested money from the Oregon State Snowmobile Association (OSSA) to pay that bill.

"Since the rain started, I need to patch a few water leaks over our bench on the south side of the building; hopefully it will warm up enough for me to get up on the roof.

"Buckshot has volunteered to sharpen the chains on our chain saws this week and tune them up. Thanks to him for that.

"We have spent 40 hours total time working on the cats this summer, driven 850 miles up and down the mountain to work on them, 20 hours driving time. Thanks to the volunteers for their time to get the cats in shape for winter.

"We spent \$6,739 on both cats. Thanks to OSSA for the funds to do this work.

"Denny Farwell, our director at large for OSSA, has requested an inventory on the shed, so I have also been working on that this past summer. It has been a trip down memory lane for me as I started grooming in the winter of 86-87 and during that time we have accumulated the equipment we have that has been donated or money raised to purchase. The Tollgate Trail Finders (TTF) club, as well as the old Oregon Trail Snowmobile Club and Skyline Club, were all involved in providing the equipment and tools we have in that building. There are too many names to list who have provided equipment and money individually, but we send a big THANKS to all those people and clubs.

"Leonard 'Buckshot' Carter wants to retire as District Director for District 8, OSSA, and has been asking about who might be willing to serve in this position. If you are interested, please contact him. You can also contact me if you have questions as I was the district director and director at large for 11 years."







Well, it looks like the Snow Gods have answered all our prayers as it started dumping snow in early November! We know a lot of people were able to get





## **Snow Shows?**

Oh, how we missed attending the great snow shows in 2020 and seeing all our snowmobiling friends. We look forward to these shows each year. I am sure you all missed attending the WSSA Snowmobile and Power Sports Expo and Swap Meet in Puyallup and the Spokane Winter Knights show in Spokane, and of courses the evergrowing Bavarian Boondockers Snow Fest in Leavenworth. Hopefully, with determination and recreating responsibly, we can say good -bye to COVID-19 and get back to our normal activities and events in 2021. If you want to know what is going on with the clubs and WSSA, be sure to visit their website to see the latest news and events.

## **Snowmobile Program Funding 101**

If You didn't register your snowmobile(s) last year, you are partially responsible for the 10% cut to the grooming budget this year and the 6% cut to the snow removal and education and enforcement budgets.

#### Here's How it Works

You register your snowmobile between August 2020 and June 2021 and you receive a Sno-Park Permit at no extra cost. (You then enjoy the coming winter season without any worry of a citation for not being registered and having a sno-park permit.)

\$50 of your registration fee is put into a dedicated account for the Snowmobile Program, (minus 3% to DOL).

The gas tax formula is applied: one hundred thirty-five gallons as the average yearly fuel usage per snowmobile, times the number of registered snowmobiles during the calendar year under determination, times a fuel tax rate of \$0.349 cents per gallon of motor vehicle fuel (minus 3% to DOL). So for your one snowmobile, you have provided approximately \$94.20 to the dedicated Snowmobile Account.

That money is then available for the following winter season – money collected for snowmobiles registered last year 2019/2020 is being used for the 2020/2021 season (this winter). The snowmobile program does not budget based on projections but on actual revenue 'in the bank'.

If you don't register your snowmobile for the coming 2020/2021 winter season, it will be that much less money available for trail grooming, snow removal, sanitation, administration, education and enforcement for the 2021/2022 winter season.

Your snowmobile registration funds YOUR program.

## Warming Huts/Shelters

We have been working with the various U.S. Forest Service Districts and most of them have responded that they will be keeping the warming huts/ shelters open this winter. Please contact the District you will be visiting for specifics. We believe it is imperative to provide these safe havens to those who may be injured, *(Continued on page 22)*

# Snowinghile Program Funding 101

Register your snowmobile and receive a <u>FREE</u> Sno-Park permit. Relax and enjoy this winter season without risk of a citation for not being registered or for not having a Sno-Park permit.

Your \$50 registration fee and money collected from a gas tax refund are put into a dedicated fund account for the Snowmobile Program.

The gas tax refund is computed using the following formula: 135 gallons (average yearly fuel usage per snowmobile)  $\times$  .349 cents per gallon of gas  $\times$  the annual number of registered snowmobiles and snowbikes.



The gas tax refund and registration fees collected each year add up to approximately \$94.20 per snowmobile or snowbike to fund the program. Fees collected this year are put towards next year's snowmobile season to pay for trail grooming, snow removal, sanitation, administration, education and enforcement.

# Names in the News

John Kerry was recently named Special Presidential Envoy on Climate Change. While Biden's transition team offered few specifics on Kerry's role, he'll be the first climate official with a seat on the National Security Council. And with 'presidential' in his title, it suggests Kerry will report directly to Biden, while 'envoy' marks him as a senior diplomat.

A top choice to lead the Defense Department under Joe Biden is a climate hawk, Michele Flournoy, who would make the military an unlikely but powerful driver of his carbon reduction policies. Flournoy, a former Undersecretary of Defense in the Obama administration, views the Pentagon as a first responder to the effects of climate change. Flournoy has said the military can be an essential part of Biden's climate policy by decreasing its significant carbon emissions and by being a large investor in clean energy.

Rumor has it President-elect Joe Biden will tap Janet Yellen as his Treasury Secretary, a pick that could play a defining role in U.S. efforts to slash carbon emissions and prepare the economy for the realities of a warming world. Yellen served at Federal Reserve under Obama and at White House Council of Economic Advisors under Clinton. On climate change specifically, Yellen's stance for years has revolved around her support for a carbon tax, which she has called a "textbook solution" to global warming.

# **Changes at Polaris**

# **NEPA Changes**

The Trump administration finalized a rule that will allow the U.S.

A CONTRACTOR

Forest Service to log and otherwise manage 2,800 acres of Forest in the West without an environmental review.

Agriculture Department Secretary Sonny Perdue said in a statement that the Forest Service needs the rule change to "improve our ability to maintain and repair the infrastructure people depend on to use and enjoy their National Forests — such as roads, trails, campgrounds and other facilities."

The logging industry says the change will help the U.S. Forest Service better manage wildfires. Conservationists say it weakens a key environmental law.

In a summary provided by the Forest Service, the agency said it is "amending its NEPA regulations as described in this final rule to make more efficient use of those resources to fulfill NEPA's requirements and, in turn, its mission.

"The final rule is consistent with the Council on Environmental Quality's intent to ensure that federal agencies conduct environmental reviews in a coordinated, consistent, predictable, and timely manner, and to reduce unnecessary burdens and delays," it said.

# **BRP Go!**

BRP has announced a new app - BRP GO! - designed to enhance how riders interact with the snowmobile community as they ride within selected U.S. and Canadian locations.

Designed for Apple and Google devices, the new app offers many perks for Ski-Doo and other snowmobile riders including navigation for snowmobile trails to ensure riders can navigate terrains safely, and specific community info (locating other riders so you always know where your friends and family are).

The app also offers both online and offline information to ensure navigation for when cell signals may be scarce. The app currently is available for riders in Massachusetts, Michigan, Minnesota, New Hampshire, New York, North Dakota, Pennsylvania, Vermont, and Wisconsin. There are plans to expand across more states in the future.

For locations currently not covered, the app will still allow riders to mirror the app on the gauge, create an account, invite friends, use the area exploration mode (without the trails) and see topographic information on the map, as well as locating your GPS position.

If you would like your region to be included in BRP GO! you can reach out to your local snowmobile association to express interest. It is the one-stop shop for planning snowmobiles outings.

# BLM back to DC?

A coalition of climate experts hoping to guide President-elect Joe Biden's transition team has suggested big changes for the Bureau of Land Management, including reversing the Trump administration's relocation of its headquarters to Colorado.

The Climate 21 Project team, in a memo outlining specific changes needed at the Interior Department, said the Biden administration should "bring BLM national leadership back to Washington" on day one.

# Names Are Popping Up Everywhere!

cording to people briefed on the matter.

Klobuchar, according to these people, is being considered by Biden and his team for a number of positions, including Attorney General and Secretary of Agriculture. Her name has risen on the list of possible Cabinet appointees since election day as the Senate remains up for grabs. They declined to be named as these deliberations have been made in private.

Other names mentioned for Agriculture include: Reps. Marcia Fudge, D-OH, and Cheri Bustos, D-IL, and Chellie Pingree, D-ME, as well as Collin Peterson, D-MN, who is losing his seat as chair of the House Agriculture Committee.

Rumor has it that contenders for Interior include Sen. Tom Udall and Rep. Deb Haaland, both New Mexico Democrats.

## Wildfires Threaten Water Quantity

How wildfires can affect water quality are well documented. But increasing—and increasingly intense—Western conflagrations are leading to fears they also constrict the water quantity available in some of the nation's



When a wildfire burns forests in a watershed, there are no trees to absorb any of the water. With the forest canopy gone, the snow is exposed to more sunshine, melting it faster - sometimes throughout the winter. And the charred remains of trees and soot falling to the ground darken the snow, making it ab-

sorb even more heat and melt faster still. All across a burn area, the forest soil repels water, preventing

rain and snowmelt from soaking into the ground, and forcing it to cascade down the mountains and flood the streams below.

The result: Snow melts earlier than usual at a time when reservoirs aren't prepared to capture the runoff, because many can't start refilling for the season until late in the spring.

If precipitation falls as rain - something more common even in cold months as the climate changes - it careens right off the slopes of a burn area, creating flash floods that jam city water intakes with soot and debris.

## **Did You Know?**

Trailing just Russia and Canada, The United States is the thirdlargest country in the world by landmass, covering nearly 2.3 billion acres.

The largest overall landowner in the country is the U.S. government, with different departments - the Forest Service, the U.S. Fish and Wildlife Service, the Department of Defense, and others - controlling different parts of federal land.

While state governments also own much land, there are also private landowners who own hundreds of thousands of acres of land across the country - and a handful own over one million acres each.

## **BRP and Arctic Cat Have Reached a Global Settlement**

Bombardier Recreational Products Inc. (BRP) and Arctic Cat Inc., a Textron Inc., have reached a global settlement of the ongoing intellectual property disputes between them. Under the terms of the confidential settlement agreement, the two court cases still active between the parties in the US and in Canada will be dismissed.

Among the matters resolved is the dispute related to BRP's riderforward patents and Arctic Cat's full-size snowmobiles with pyramidal frame designs. As a result, Arctic Cat and its Canadian dealers will be allowed to immediately resume the sale and delivery of its full lineup of snowmobiles in Canada.

Arctic Cat and BRP have pledged to continue to work together for the betterment and expansion of the snowmobile industry for all riders and associations.



# US Department of Commerce releases economic output data for outdoor recreation

The U.S. Department of Commerce, Bureau of Economic Analysis, has released the Economic Output for outdoor recreation for this past year. The recreation industry generated \$788 billion dollars in 2019, which is \$10 billion dollars higher than in 2018. The outdoor recreation economy continues to grow and outperform the economic growth in the United States during the pandemic. Individuals are continuing to reach out and recreate in the great outdoors across the United States.

The latest report shows outdoor recreation, as part of the Gross Domestic Product (GDP), is 2.1%. What does that mean you ask? Outdoor recreation produces more of the GDP and is bigger than mining and agriculture! Snow activities, including snowmobiling, grew 3.1%. Most of that activity is within rural America and is the economic engine for many rural families and their economy.

Outdoor recreation generates 5.2 million jobs in the United States. The states with the largest percentage of state GDP related to outdoor recreation are Hawaii, Vermont, Montana, Florida, Maine, and Wyoming. In Montana, 32,000 jobs are generated by the outdoor recreation economy which is 4.7% the 6th largest of the economic activities. Snowmobiling is an important part of the overall recreation economy and we generate economic activity during peak winter months when much of rural America is in need of economic output and support.

The recent study underscores individuals who are outdoor enthusiasts are active in the winter and warmer weather as well. Surveys by ISMA show that approximately 60% of all snowmobilers also ride ATVs and UTVs in the summer. More than 50% of snowmobilers enjoy boating and fishing and recreational camping. Outdoor recreation enthusiasts participate in many activities and they are healthy, strong, and do not participate in a great deal of TV watching and internet-based recreation.

The snowmobile manufacturers and the snowmobile community are pleased to participate with the studies conducted by the Bureau of Economic Analysis within the Department of Commerce. We provide supporting data and information to the Department upon request. # Millennial and Gen Zs: They Are Snowmobiling's Future

There may be a couple million snowmobiles registered in the United States and snowmobiling does generate billions of dollars annually nationwide, but the average snowmobiler is forty-five years old. Who will be the individuals to take charge of the snowmobiling industry when current older members grow out of such an enjoyable sport? That is the job of the Millennials and Gen Zs. Snowmobile clubs and associations around the world need to continue promoting the sport snowmobiling to Millennials and Gen Zs, because they are the future of snowmobiling. Whether it is through technology, fundraising, or local events, the sport of snowmobiling can be made so easily accessible to Millennials and Gen Zs especially.

Technology is the most effective and efficient way to promote the sport of snowmobiling to Millennials an Gen Zs. Facebook, Instagram, and Snapchat are majority used by Millennials and Gen Zs. This world we live in is starting to transform from all documentation, advertisements, and ways of communication from paper to online. The snowmobiling industry needs to follow the trend. On the daily I see hundreds of online advertisements about makeup, sporting events, and weight loss plans, but I rarely come across snowmobile advertisements. All the advertisements I encounter are aimed for Gen Zs and Millennials to see especially. This is where the snowmobiling industry can put their foot in the door to promote the sport of snowmobiling to Gen Zs and Millennials. Snowmobile clubs and associations need to construct electronic advertisements geared towards Gen Zs and Millennials. These advertisements should include how enjoyable the sport of snowmobiling is, and explain that one doesn't need a brand new expensive snowmobile or have to ride in the X-Games to get involved with snowmobiling. Advertisements should also be made clear that Gen Zs and Millennials are indeed the future leaders of the snowmobiling industry, and should explain how valuable they are to the industry itself. In the small community I live in, high school sports games especially are advertised, mostly over Facebook, the student section Instagram page, and on Snapchat stories. This is where the Gen Z, Millennials, and any other age that is already involved with snowmobiling can help the snowmobile industry grow. Simply make a post about an upcoming snowmobile group ride, or reaching out to friends to come try out riding a snowmobile can spark an interest in snowmobiling. All the snowmobile associations and clubs should also make Facebook, Instagram, and a Snapchat account to post information about local and statewide snowmobiling opportunities. When shared, there is a guaranteed that Gen Zs and Millennials around the world will see the information.

Snowmobile fundraisers and events are also ways to promote the sport of snowmobiling to Gen Z and Millennials. An example of a really successful fundraiser that my local snowmobile club holds yearly is called Winterest. We constructed a snow racetrack in a parking lot of a local business surrounded by large resorts. This track is open to any member of the resorts to come and try out. For the youth we hold 120-cc snowmobile races around the track, and for anyone else to tall for a 120-cc snowmobile, we hold and egg and spoon race around the track. The track is the most popular part of the fundraiser because of how many individuals come to try out the racetrack, most of which are Gen Zs and Millennials. Inside of the restaurant we held raffles and other hands on snowmobile activities for anyone to try. Hands on activities should be the basis for every snowmobile fundraiser or event to help get Gen Zs and Millennials involved. Being able to



physically try snowmobiling even at a small event is enough to spark an interest in snowmobiling for and individual. Snowmobile fundraiser and events are also effective because they get the community involved. Driving through a small town and seeing a massive Tucker Snocat parked on the side of the road is enough for individu-

als to check it out, and maybe even turn around and join in on the fundraiser. Or the big talk in a local elementary school about having a 120-cc snowmobile race is enough for the youth to ask their parents if they can attend the event. All of the conversations of such intriguing opportunities a fundraiser includes within a community, will attract people, especially the Gen Zs and Millennials because they most likely have the most time on their hands to try new things.

Local snowmobile clubs and associations need to continue to reach out to the youth and ask them if they want to participate in what older members may just do automatically. Yes, older members may know the land the best for trail marking, but the youth will never know the land if they are not given the opportunity to learn. Asking the younger members of a club to come learn for the future is definitely a way to get them involved with snowmobiling. Many members may not know that there is more to snowmobiling than just getting out on the trail and riding. The bookkeeping, committees, trail marking, fundraising, and trail grooming need to be taught to the younger generations. Current snowmobile leaders need to teach and include the younger members with everything they participate in with snowmobile clubs. For example, my father is one of the main snowmobile groomers for my county. Over the past two years, he has let me come along when he goes grooming, and this past year he has let me drive the groomer for quite a few trips out on the trail. I would have never been exposed to trail marking, grooming, fundraising, and the bookkeeping if it wasn't for my father. There are so many snowmobile leaders in clubs and associations, and all they need to do is ask for the Gen Zs' and Millennials' participation.

The continuing promotion of the sport of snowmobiling to Gen Zs and Millennials is crucial to the future of the snowmobiling industry. There are so many ways to advertise snowmobiling, whether it is electronically, through fundraisers, and even by snowmobile leaders themselves. New younger leaders will come as a result, and they will be the ones promoting the sport of snowmobiling to new generations to come.

Washington Hometown Snowmobile Trail App update. If you read the ACSA E-News a few pages back... of course you did because you didn't skip to this page first... you saw the snippet about BRP GO!, Bombardier's new trail app. You probably noted Washington wasn't included in the initial trail map role out. I did too, so I sent a note to Jennifer Hackett at Washington Hometown and asked her if she was aware of the app, and that Washington was absent. As it turns out, she was and told me the following, which includes updates on the Washington Hometown app.

"We actually are partnering. I have signed a contract with TrakMaps that includes BRP. They are subscribing to the snowmobile data which they will use on both TrakMaps and BRP. TrakMaps isn't releasing their product until next year, but I believe the data will be integrated into BRP this year. I am just finishing up a major clean-up of the trails data, which will be integrated into BRP this season.

"And ONX is also subscribing to the data. "Trak Maps/BRP is also interested in snowmobile data for the surrounding states as soon as I wrap up the current apps, I plan to start talks to expand.

"Please ask groomers and regular riders to check the maps and let me know if there are any corrections. I have spent the last week cleaning up the data - and there are some odd places where the State Parks mapped trails take odd jogs off the recreation road that the trail is riding over - I am trying to verify those, but if anyone sees anything however minor - i can fix it and post the fixes to all four platforms (Snowmobile WA, ONX, BRP and, next year, TrakMaps).

"Also, we just released the update to our OHV WA app and it looks really good."

Keep in mind Jennifer is always seeking our input for updates, corrections and suggestions to make the maps/app better. Having a local, responsive ear is something you won't get with most app developers.

Meanwhile in Wyoming... Did you know the Bighorn National Forest regulations state that motorized over-snow vehicles (such as snowmobiles and snow bikes), off road or trail travel, is not permitted until November 16th annually? Even after November 16th, there is a requirement for at least six inches of snow to be present before vehicles can be driven off the route and resource damage cannot occur. This is not an arbitrary requirement and several snowstorms and layers of snow must settle to form a base before the land is adequately protected. This year, Bighorn National Forest law enforcement officers issued violation notices to those who could not wait. Those individuals not only have to pay high fines but could eventually lose their privilege to visit the National Forest. This info came from a Bighorn National Forest press release and they also urged users to preserve their access and avoid the fine. I'm surprised somebody was out riding in six inches of snow in the first place. (That is still ATV/UTV season right there!)

My stash includes a shovel and saw which are used on nearly every ride. Under that is stuff to build a fire and space blankets to keep warm. A few packages of trail mix to keep me from starving. First-aid kit and other safety-related items. And a tow strap.

Probably the most important item I carry in my pocket is my SPOT receiver. This was a concession I made to my wife and daughter years ago and it is 'on' and in the 'tracking' mode anytime I'm out in the woods (winter or summer). I've only used it once in an emergency (for someone else), and it

Pre-trip planning is pretty important too. I'm a fair-weather rider, so I try and pick days that aren't going to be blizzard-like, preferring sunny and dry; a perk of being retired is not having to cram riding into weekends regardless of the forecast. I check the avalanche forecast too, and I work to avoid this type of terrain anyway since I prefer to ride through the trees and not play on the hills.

Everyone will tell you to not ride alone and this is good advice. I adhere to it... mostly... although I'd be lying if I said I don't venture off at Tollgate when I'm at our cabin by myself. Save the lecture. Do you want to know what can be worse than riding by yourself? Riding with the wrong people. Pick your riding groups carefully - you don't want to ride with people who don't ride safe and who make poor decisions themselves. Peer pressure is a thing, and as much as we think we can ignore it, we all get sucked in occasionally. I ride with a good group of like -minded people I trust.

Summary? Ride safe. Ride with a trusted group. Be ready to extract yourself. Be prepared to spend a night out in reasonable comfort if you have a failure in any of the first three.

P.S. My daughter's sled is equipped with the same box and same contents for double the fun!
